DATA CONTROLLER, PURPOSES and LEGAL BASES OF PROCESSING

Carbon Credits Consulting S.r.l. (hereinafter, **CCC**) in the person of its pro tempore Legal Representative, Via del Monte 10, Bologna (BO) - 40126, is the **Data Controller** of the personal data of users collected during the use of the services of this website.

CCC will process the personal data it comes into contact with in compliance with the principles of lawfulness, fairness and transparency as well as the provisions of law and regulations for the following purposes:

1. Access to the website and browsing;
2. Management of requests for information;

In detail, the use of personal data for access to the site and browsing activities involve the processing of data to implement measures adopted at the request of the data subject, which is the legal basis that legitimizes the processing. The use of personal data for the management of further processing operations, together with the specific legal bases for the processing, are described in the section of this policy on the principles applicable to CCC's data processing.

PLACE OF DATA PROCESSING

The processing related to the web services of this Site takes place at the aforementioned registered office of the Data Controller and at the hosting company providing the service.

CATEGORIES OF PERSONAL DATA

Browsing data

The computer systems and *software* procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

This information is not collected to be associated with identified data subjects, but by its very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes the IP addresses or domain names of the computers used by users who connect to the site, the *URI (Uniform Resource Identifier)* addresses of the resources requested, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the *server* (successful, error, etc.) and other parameters related to the user's operating system and IT environment.

These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in the event of computer crimes against the site or the Data Controller: except for this eventuality, at present, the data on *web contacts* do not persist beyond the terms of the law.

Data provided voluntarily by the user

The optional, specific and voluntary sending of e-mails to the addresses indicated on this site involves the subsequent acquisition of the sender's address by the CCC, which is necessary to respond to requests, as well as any other personal data included in the communication.

Specific summary information will be reported or displayed on the pages of the site prepared for particular services on request.

Personal data

Through the functionalities within the CCC website, the user can provide certain personal information about himself that can be made personally identifiable and that can be processed in order to manage, for example, the latter's requests.

Among the information that may be requested, there are, but are not limited to, personal data such as:

1. Name and Surname
2. Phone Number and Email Address

PRINCIPLES APPLICABLE TO DATA PROCESSING BY CCC

CCC will treat your personal data in a lawful, fair, and transparent manner.

The Data Controller will collect users' personal data and process them only for the purposes indicated in this Privacy Policy and in such a way that they are not incompatible with the purposes themselves.

The data processed by CCC is adequate, relevant and limited to what is necessary for the purposes for which it is processed, including:

1. REQUESTS FOR INFORMATION AND CONTACTS

The Data Controller will process the personal data of users who fill in the appropriate online forms for requesting information regarding the initiatives, projects, products or services offered by CCC in order to manage, verify and provide what the data subject has requested. The data will be recorded, stored and used to respond to the requests of the interested parties and for the time necessary to achieve the aforementioned purpose. The legal basis for this processing is the execution of pre-contractual measures taken at the request of the data subject (Art. 6, para. 1 lit. b) GDPR).

The provision of data for this processing purpose is optional. However, failure to provide data, partial or incorrect provision of data may make it impossible for CCC to manage and follow up on user requests.

SOCIAL PLUG-IN

This website uses the so-called "*social plug-ins*".

"*Social plug-ins*" are specific tools that allow you to embed the functions of the *Social Network* directly within the website.

All "*social plug-ins*" on the website are marked with the respective logo owned by the social networking platform.

When you visit a page of our website and interact with the "*plug-in*" or decide to leave a comment via the social platform, the corresponding information is transmitted by your *browser* directly to the relevant social platform and stored there.

METHODS OF PROCESSING

Personal data are and will be processed, in paper and/or digital form, for the time strictly necessary to achieve the purposes and purposes for which they were collected.

No automated processing of the data collected, including user profiling, is active.

Specific security measures are observed to prevent the loss of data, illicit or non-illicit use and unauthorized access.

CATEGORIES OF SUBJECTS TO WHOM THE DATA MAY BE COMMUNICATED (RECIPIENTS)

The parties to whom CCC may disclose data act as Data Processors personal data designated through specific agreements or as persons authorised to process personal data by the Data Controller. Finally, the data may be communicated to the Company and/or External professionals to fulfil specific obligations imposed on the Data Controller by current legislation. The interested party, by requesting access to their personal data, can obtain the list of recipients of their personal data by writing an e-mail to compliance@carboncreditsconsulting.com

RIGHTS OF THE DATA SUBJECTS

The interested users of the Site have the right, pursuant to art. 15-22 GDPR, of:

- **Request access to personal data:** You have the right to obtain confirmation from the Data Controller as to whether or not personal data concerning you is being processed and, if so, access to the data. Access may be directed to obtaining the following information:
 - The purposes of the processing;
 - The categories of personal data in question;
 - The recipients or categories of recipients to whom the data have been or will be disclosed, in particular if they are intended for third countries or international organisations;
 - The retention period of personal data or the criteria used to determine this period;
 - The existence of the right to request the Data Controller to rectify or delete the data or to limit the processing or object to the same;
 - The existence of automated decision-making.
- **Request for rectification of personal data:** You have the right to obtain the rectification of inaccurate personal data concerning you, as well as to obtain the completion of incomplete personal data.
- **Request for deletion of personal data:** for the reasons indicated in Article 17 of the GDPR, the data subject has the right to request the Data Controller to delete the data without undue delay and the Data Controller has the obligation to delete the personal data of the data subject, provided that there is no statutory retention obligation on the data.

- **Request for restriction of data processing:** In the event that one of the hypotheses referred to in Article 18 GDPR applies, the data subject has the right to request the restriction of the processing of data concerning him/her.
- **Request for data portability:** the data subject has the right to receive in a structured, commonly used and readable format, the personal data concerning him or her provided to a Data Controller and has the right to transmit such data to another Data Controller if the processing is based on consent, on a contract or is carried out by automated means.
- **Request to object to processing:** You have the right to object to the processing of personal data concerning you at any time, on grounds relating to your particular situation.
- **Withdrawal of consent:** The data subject has the right, at any time and with the ease with which he or she has given it, to withdraw consent to the processing of his or her personal data.
- The data subject also has the right to lodge a complaint with the Italian Data Protection Authority (www.garanteprivacy.it).
